ANNEXTURE 1: AFFILIATED RANGES (ARTICLE 10)

- 1.1. As per Article 10 of the constitution the following ranges are recognised under written agreements as “Affiliated Ranges”:
 - 1.1.1. **Ihawu Firearm Centre**
Affiliation duration: 01 March 2026 to 28 February 2027
Operating times: 07:30 – 16:00 Mon - Sun
Location: 111 – 115 Escom Road, New Germany, Pinetown, KwaZulu-Natal.
 - 1.1.2. **The Mapstone Shooting Range**
Affiliation duration: 01 March 2026 to 28 February 2027
Operating times: 07:30 – 16:00 Mon - Sun
Location: Richmond KwaZulu-Natal
- 1.2. With regard to 1.1.2, club members are encouraged to affiliate separately to the Mapstone Shooting Club to be allowed to use this facility as it is not covered under all membership tiers.
- 1.3. This affiliation can be done through the club for an additional annual fee as per Article 13, Annexure 2.

- 2.1. Annual Membership Fee structure for the year 01 March 2026 - 28 February 2027:
 - 2.1.1. Once-off Administration Fee – New Membership:
 - 2.1.1.1. R 200.00
 - 2.1.2. Once-off Administration Fee – Late Renewal:
 - 2.1.2.1. R 200.00
 - 2.1.3. Annual Standard Membership Fee – UBIQUE:
 - 2.1.3.1. R 1 000.00
 - 2.1.4. Annual Fee – MAPSTONE:
 - 2.1.4.1. R 250.00
 - 2.1.5. Honorary Members and Honorary Life Members:
 - 2.1.5.1. Free / R 0.00
 - 2.1.6. “Green Fees” or “Range Fees” per day at UBIQUE:
 - 2.1.6.1. Free / R 0.00
 - 2.1.7. “Green Fees” or “Range Fees” per day at MAPSTONE:
 - 2.1.7.1. R 250.00
 - 2.1.8. There will be a single Membership Fee Structure or as described in Article 13.
 - 2.1.9. Administration Joining Fee will be updated on an annual basis.
 - 2.1.10. All Tiers of Membership renewal fees will be updated on an annual basis, if this fee lapses the administration fee will need to be paid again prior to the renewal fee being accepted.
 - 2.1.10.1. Membership is considered lapsed if unpaid by midnight on 30 April of every year invoking Article 14.
 - 2.1.11. Where applicable range green fees will be payable at each event at the rate per 2.1.6 and 2.1.7.
 - 2.1.11.1. These rates will be updated on an annual basis.
 - 2.1.12. Discounted range fees will only apply on the presentation of a Club membership card showing that which tier the member is on and that they are in good standing with the Club.
 - 2.1.12.1. In the event a new membership card has not been issued, then proof of payment of fees will need to be produced.

 - 2.2.1.2. Invited to attend organised UBIQUE club shoots at UBIQUE and MAPSTONE shooting ranges.
 - 2.2.1.3. Access to Mapstone shooting range on non-club days.
 - 2.2.1.4. Option to be added to the club WhatsApp group.
 - 2.2.1.5. Option if active in club events or registered with a sporting body such as SAPSA to purchase a club shirt or clothing.
 - 2.2.1.6. Includes all range fees at UBIQUE shooting range for duration of membership.
 - 2.2.1.7. Includes all range fees for UBIQUE club shoots at MAPSTONE for duration of membership.
 - 2.2.2. Standard Membership:
 - 2.2.2.1. Membership of UBIQUE (2.1.3) shooting club.
 - 2.2.2.2. Invited to attend organised UBIQUE club shoots at UBIQUE.
